2. **PUBLIC HEARING TO FINALIZE THE BUDGET AND ADOPT MILLAGE RATES:**

- a. Ordinance No. 4957 (City Clerk reads ordinance *in full*.)

An ordinance of the City of Boca Raton adopting final millage rates and levying ad valorem taxes for the fiscal year beginning October 1, 2006 and ending September 30, 2007; stating the percentage by which the millage to be levied exceeds the "rolled-back rate"; directing the City Manager or the Office of Management and Budget Director to adjust the adopted millage rates in the event of changes in the assessment roll and taxable value; providing for severability; providing for repealer; providing an effective date

- b. Ordinance No. 4958 (City Clerk reads ordinance title.)

An ordinance of the City of Boca Raton adopting a final budget and appropriating funds for the fiscal year beginning October 1, 2006 and ending September 30, 2007; providing for severability; providing for repealer; providing an effective date

- c. Discussion, public comments and explanation of "percentage increase in millage over the rolled-back rate necessary to fund the budget, if any, and the specific purposes for which ad valorem tax revenues are being increased."
- d. Open public hearing on final budget and final millage rates.
- e. City Council "shall amend the adopted final budget as it sees fit."

- i. Close public hearing.
